DON'T LET FIRE CLAIM YOUR ANTIQUE AUTO

One of the major causes for loss of antique cars is fire. We must be very conscious of this fact and put more effort into preventing and dealing with fires.

Take the following precautions:

- Disconnect the battery.
- Check cans of chemicals, oil and other unnecessary inside the vehicles for paper, rags, items.
- Check the storage space where vehicles are kept for unnecessary paper, rags, cans of chemicals, etc.
- Keep combustible chemicals in metal, not glass, containers.

Should a fire occur, call the fire department. Try to contain the fire until help arrives. Your first line of defense is a fire extinguisher. Know how to use it and be positive it is the correct type. Fires are placed in 4 classes:

- CLASS A: Wood, cloth and paper fires.
 Water will bring them under control.
 Never use a Class A extinguisher on electrical, chemical or any other type fire.
- CLASS B: Gasoline, oil, paint, grease and natural gas fires. Use foam, dry chemicals or CO2 extinguishers.
- CLASS C: Electrical fires. Use dry chemicals or CO2 extinguishers.
- CLASS D: Ignitable metals. Use only a



Here Comes da Judge

Many car owners ask what goes on during the judging at a car show. Well, this is my perspective of car show judging.

We all go to car shows for a number of reasons: see our friends, look at the other cars and, of course, to show our cars to others. The only recognition (aside from the occasional "nice car" remark) we get for all the time, work and money is in the form of a trophy. In order to effectively award trophies, somebody has to inspect the condition of the vehicle. These somebodies are called judges.

The chain of events leading up to the actual judging can be quite a feat. First you have to have a Head Judge. He/she is the person in charge of the judging team and is usually qualified and ready to make on-the-spot judging decisions. Then, the Head Judge has to coerce thirteen more people to volunteer a couple of hours of their time. These thirteen people represent ten judges, one alternate and two writers.

Once the judging team has been assembled, the Head Judge will brief them on the judging sheet, points system, what to allow or overlook and the good old CC&W (cleanliness, condition & workmanship). The Head Judge also charges all the judges to help with authenticity.

Duriing the briefing, the judges select their inspection areas by random drawing. Each judge will judge the same items on every vehicle at the show. The only exception being his/her own vehicle or, in some cases, his/her class. This method assures judging consistency; the same eyes look at the same areas on every vehicle.

How the points are awarded by a judge varies from judge to judge. Some start off thinking a car is a 10 and deduct from there. Some start at zero and go up. I recently heard a judge say he starts with a 5 and goes from there. It doesn't matter how a judge goes about it as long as he/she is consistent. How do we monitor this consistency? With the writers.

The writers are the people that stand at the front of the car with a clipboard and judging sheet. The judges inspect their

specific area of the vehicles and, in a quiet voice, tell the writer what his decision is. The Head Judge will periodically ask the writers how the numbers are going and if they seem consistent. If they are not, the Head Judge will correct it.

While the judging is ongoing, runners will collect the completed judging sheets and take them to the tally people. These talliers add up each judging sheet, double check it and record the total score in the "book."

Following the tallying is what we all crowd around the tent for - trophy presentation. As you would guess, the vehicle with the highest score in its class gets the first place trophy. Next highest is second place and so on.

What can we as car show registrants do to make the judging process easier for the judging team? (1) Have the judging sheet accessible. The easiest place to put it is on the drivers seat. (2) Have your vehicle presented properly. Have the top up and the hood and trunk open. (3) Stay a respectable distance from your vehicle and let the judges do their job. In other words, keep out of their way but stay close enough in case they need your help or need an authenticity question answered. (4) Don't challenge the judges to find something wrong with your vehicle (they will).

How does the judging process help you as a vehicle owner? It lets you know how others see your vehicle. Most shows will give your judging sheet if you request it in writing and include a self addressed, stamped envelope. The completed judging sheet will tell you your vehicles weak areas. Even a blank judging sheet will let you know the areas the judges will be inspecting.

Good luck and see you at the car show.
