# We Did It Again!

DSR's 13th annual car show was absolutely outstanding and all of the members who worked before and during the show are to be congratulated. It came off without a hitch and everyone has a right to be proud of themselves and our club.

All of the competitors who were going for Re-Certification of their Prestige Awards made it and we presented four new Prestige medallions this year. 



# **Dedication Keeps Firefighter Going**

Mobile Country group honors veteran Fowl River VFD member for outstanding example he shows new volunteers

Charles Lyles has fire in his blood. When there's an emergency, he drops everything and rushes to the scene, said Roger Vines, chief of the Fowl River Volunteer Fire Department, where Lyles is a volunteer

"He's like the old fire horse. When the alarm comes in, he shuts down and goes," Vines said, explaining that in the old times, the horses that pulled fire wagons got so excited when the bells rang that sometimes they'd run away before the firemen were ready.

Lyles was selected to be Firefighter of the year by the Mobile County Association of Volunteer Fire Departments April 20. A volunteer with the Fowl River Department for more than 27 years, Lyles has accumulated a total of about 32 years as a fire fighter, including service with Flomaton and the U.S. Air Force

"It's a job that I've felt has always needed to be done said Lyles, 53. "I'm going to try to stay active as long as I can." Lyles said that he realizes that if young people are going to enthusiastically become involved with the volunteer department, they need to see dedication from the older members. Serving as a positive role model was only one of many ways Lyles serves his community, his chief said. "His

commitment was further demonstrated during the last year when he took a virtual piece of junk and turned it into an asset for the community," Vines wrote in his nomination essay.

Lyles redesigned and rebuilt a 1976 Ford service truck that had a broken frame and extensive rust damage. A replacement for the 20-year old vehicle, which had only 34,000 miles on it, would have cost the department about \$65,000. But the owner of a one-man wrecker/auto repair shop saved the department close to \$60,000 when he went to work on the 20-year-old truck.

It wasn't the first time Lyles had redesigned that truck. In 1976, Lyles and other volunteers took a 1946 firetruck and the 1976 Ford, which consisted of only a cab and a frame, and created a quick-response pumper truck, Lyles said. truck, which stayed outdoors so the service would be quicker, was key to saving a lot of houses and property, he said. But years in the wind and rain took their toll. Lyles rewelded rusted and broken parts and built a stainless steel cover. He also adorned it with a new coat of shiny, red paint. "We really used the tar out of it. It looks good. It's sharp," he said. That's not the only way that Lyles has used his business to held the fire and rescue department. Trained as a first responder for medical emergencies, he also responds to many accidents, arriving in his wrecker so that he can move vehicles out of dangerous positions. Whenever he can, Lyles closes his shop to respond to emergency calls, Vines said. "He does it and doesn't make a big production about what he does," Vines said. "A lot of times he goes unnoticed, just because of the way he does things."

Lyles pointed out that many other volunteers were as worthy as he and said he felt fortunate that his peers nominated him. "I'm very proud of it, to be honest with you," he said.

# **Baffled by Insurance Coverage?**

Some members are confused between the club's insurance coverage through J.C. Taylor and an individual's own insurance coverage for his/her antique autos. I have obtained information from Al Callazzo with J.C. Taylor which may help to somewhat clarify the issue. He has provided an overview of the coverages provided within their Antique & Classic Auto Club Program policy. Bear in mind that it does not take the place of the actual policy and is, of course, subject to all terms, conditions and exclusions of the policy.

WHAT COVERAGE?

Commercial General Liability Non-owned Auto Liability

WHO IS INSURED? The Named Insured (The Club), all its Members including Officers and Director. Coverage is limited to Bodily Injury and/or Property Damage Liability arising out of an occurrence associated with activities of The Club.

WHERE IS COVERAGE? Clubs are covered for any occurrence on property rented, leased or used by the Club for Activities of The Club. Activities include, but are not limited to meetings, dances, tours, picnics, flea markets, banquets, shows, malls, shopping center shows, and parades.

WHAT COVERAGES? Coverages are listed below. The items listed are a <u>limited</u> summary of the coverages under the General Liability and Non-owned Auto Liability.

- 1. Basic Insurance Agreement: The policy will pay those sums which the insured becomes legally obligated to pay as damages because of "bodily injury" or "property damage" to which the insurance applies.
- 2. Personal Injury Liability
- 3. Advertising Injury Liability
- 4. Contractual Liability
- 5. Products Liability
- 6. Non-owned Watercraft Liability
- 7. Liquor Liability
- 8. Non-owned Auto Liability

There are many topics not discussed in this summary and no coverage is provided by this summary. Also this brief summary is not a complete explanation of the policy. A narrative description can never replace a policy.

One of the most important statements in Mr. Callazzo's cover letter to me is highlighted and I quote:

"As I advised you in our telephone conversation, there is no owned automobile liability coverage in the Club Program policies (each vehicle owner must obtain it)."

If your antique automobile insurance coverage is through J. C. Taylor you can get information on your policy by calling 1-800-345-8290 or if you should have a claim (Heaven forbid!) that number is 1-800-272-6768.

You should consider carefully how you use your antique automobiles when not participating in Their application form has a club functions. statement which reads "My vehicle(s) will be used mainly in exhibitions, club activities, parades and other functions of public interest and will not be used primarily for the transportation of passengers or goods. If you are a resident of FL, PA or NJ, please send a copy of daily use car policy." This is not to say that if you had an accident when using your antique auto for personal use that you would not be covered but rather to encourage you to make sure you know exactly what your coverage is. According to Bob Wallace with J.C. Taylor, every claim is looked at on an individual basis and handled in an efficient and timely manner.

The point of this entire article is that you should know what coverage you have for what use of your antique autos regardless what company your policy is through. Finally, I am not an expert on insurance coverage but you can obtain information by calling your carrier.

# Finances...Money...or What it Takes to Run Our Club

I am aware, as most of you are, that it seems like every meeting we have some sort of discussion about money; either a way to raise funds or how to stretch those that we have.

It has been my experience, having belonged to several professional organizations during my working career, that these discussions are one of the quickest ways to turn members off attending meetings or in some cases renewing their membership. But since we have acquired several new members in the past 2-3 months, I wanted to make them aware of why we do things and where the money goes.

DSR is extremely fortunate to have a great clubhouse in a prime location convenient to almost all of our members. But there are always two sides to everything and the other side of this that we have to not only maintain the clubhouse but have enough operating funds to keep the club going.

Below are some figures that I think all of you can relate to and that will show you why we put on car shows, do displays for grand openings, transport weddings, and take advantage of opportunities that will help make a few bucks for the club.

I expect that our insurance premium will be more when it comes due in November due to our having to increase the amount of coverage with the addition on the building. There are some expenses we incur that are not listed above such as toner for the copier, paper to print the Roster and other occasional items. We received 1 ream of paper per month from Office Max in exchange for their ad which is a big help. We usually make enough on the

50/50 Pot to pay for refreshments and small items such as stamps for the Treasurer. When something big comes up such as a new drum for the copy machine at \$184.00, it can really throw a monkey wrench in our budget if it is running close. When I became Editor of the newsletter, I wanted to make it self-sufficient since postage for it is one of our biggest expenses. Presently we have 3 paid advertisers, 1 on an exchange basis and 2 that either do something for the club at no cost or at a very reduced rate. Income from these advertisers is \$300.00 per year which almost pays for postage.

Local membership dues are \$15.00 and as of January 1 we had 68 members. The math reads:

\$15.00 X 68 = \$1,020.00 Revenue -  $\frac{2,229.48}{(1,209.48)}$  Expenses

You can see that everything is cut to a barebones amount and there will be some months when the utilities run more or we may have to have the grass cut 7 times instead of 6 which increases our expenditures. A conservative estimate on a year's worth of expenses would be \$3,000.00

This is why we do all the things that we do in order to raise funds. It is why members are always willing to help with fund raising and maintaining our building and grounds and all of you who participate in any of these things deserve a pat on the back.

The addition to the clubhouse is almost complete. Our Hooters Car Show which is scheduled for Oct. 26 should provide enough profit for us to finish it without any problems and we can all relax a little.

So, if you are a new member or perhaps one of long-standing that has never really given much thought to how we spend our money, now you know. Or at least I hope you know more than you did. The financial report is prepared and distributed at the monthly meetings. It is not just for your information but for you to read thoroughly and ask questions about items on it if you do not understand something. Questions and suggestions are not only welcome but encouraged. Share your ideas with us and become involved in running your club because it does belong to everyone.
