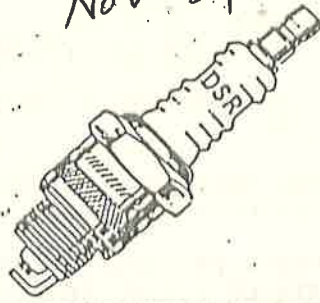

October 26, 1989

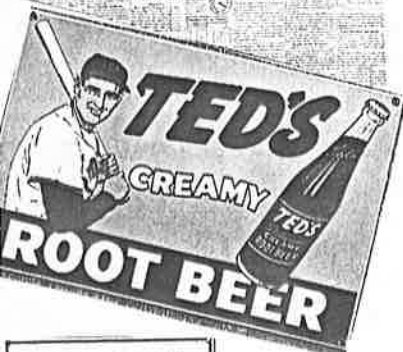

The end of the year is fast approaching and everyone should send in their AACA and DSR dues as soon as possible.

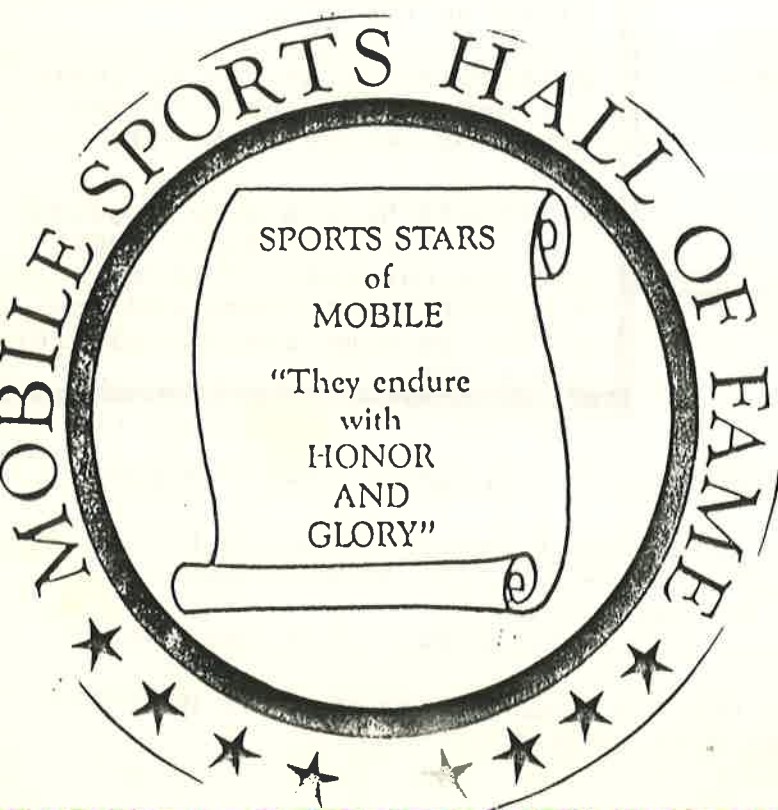

BY-LAWS OF THE DEEP SOUTH REGION OF THE ANTIQUE AUTOMOBILE CLUB OF AMERICA
(REVISED November 1989)

ARTICLE I - NAME AND PURPOSE

SECTION 1 : This Region shall be known as THE DEEP SOUTH REGION of the ANTIQUE AUTOMOBILE CLUB OF AMERICA (AACA).

SECTION 2 : The purpose of this Region shall be to supplement the activities of the Antique Automobile Club Of America, and to provide mutual enjoyment for members.

ARTICLE II - EXECUTIVE BOARD

SECTION 1 : The Executive Board shall consist of the six officers of the Deep South Region, one elected member (member at large) holding no other elected office, and the Presidents of all Chapters.

SECTION 2 : The Executive Board shall have the power to proceed in any manner as may, in their judgement, serve the interest of the Region. The decision of a majority of the Executive Board, on any question, shall be binding on the Region. However, any member of the Region at the next regular or special meeting of the Region, may challenge the decision of the Board and by majority vote of members in good standing may rescind the decision of the board.

SECTION 3 : MEMBER AT LARGE The Member at Large will be present at all Executive Board meetings and vote on all matters before the Board. The Member at Large shall be elected during the regular elections.

SECTION 4 : Vacancies in the Executive Board for any cause shall be filled by a majority vote of the Executive Board. Those elected shall serve for the unexpired term.

ARTICLE III - OFFICERS

SECTION 1 : The elected Officers of the Region shall be: President, Vice President, Secretary, Treasurer, Activities Coordinator, and Editor of Regional Publications. The term of office shall be one year beginning on January 1 following the election.

SECTION 2 : Any officer or member of the executive board may be removed from office for good cause by three-fourths (3/4) majority vote of the members. The vote of the membership shall be by voice vote on a roll-call basic at a regular meeting after (7) day notice that such vote is to be taken. Removal under this article shall be effective immediately after voting.

ARTICLE IV - DUTIES OF OFFICERS

SECTION 1 : PRESIDENT - The Regional President shall preside at all meetings of the Regional members and Executive Board and shall appoint committee chairpersons as deemed necessary to carry out the functions of this Region. The President shall have the power to decide all questions of equal division, and have all powers and duties usually vested in the President of an organization. In the absence of the President, the Vice President shall preside. If the President and Vice President should be absent, the Secretary or the Treasurer may preside.

SECTION 2 : VICE PRESIDENT - The Vice President shall serve as an aide to the President and shall perform the duties of the President in the event He/She is absent. The Vice President shall also serve as Chairperson of the Building and Grounds Committee.

SECTION 3 : SECRETARY - The Secretary shall keep written minutes of all meetings of the members and meetings of the Executive Board and will also serve as corresponding secretary for the Region. The Secretary shall perform any other duties as assigned by the Executive Board.

SECTION 4 : TREASURER -

(a) The Treasurer shall receive and disburse all funds of the Region. The Treasurer will establish and manage an account, or accounts, in such bank as may be designated by the Executive Board.

(b) The checks or drafts in the name of the Region can be drawn with the signature of two of the following (non family members) officers: Treasurer, President, Vice President or Secretary.

(c) The Treasurer will pay insurance bills, public utilities, and Regional Publication expenses upon receipt. All other bills will be paid when approved by the Executive Board or approved by a majority vote of members at meeting.

(d) Any funds set aside for the annual car show expenses shall be so designated on every Treasurer's report.

(e) The Treasurer shall collect all dues and keep record of same.

(f) The Treasurer shall render a financial report to the Region at regular meeting, and whenever the President or the Executive Board require such a report.

SECTION 5 : ACTIVITIES COORDINATOR - The Activities Coordinator shall coordinate all activities in which the Region participates. The Coordinator should be aware of any National AACA activities so as to not have a conflict with Region activities.

SECTION 6 : EDITOR OF REGIONAL PUBLICATION - The Editor of Regional Publications shall cause to be published and distributed to the members of the Region, the Regional publication, (the "Sparkplug"), the membership roster, and other publications as may be directed by the Executive Board.

ARTICLE V - ELECTIONS

SECTION 1 : The nominating committee shall be appointed by the Executive Board prior to the September meeting. The nominating committee shall present candidates for office at the October meeting. At this time, other candidates for office shall be accepted from the members. Candidates for office shall be elected at the November meeting by secret ballot on which there shall be a space for writing in candidates.

SECTION 2 : A majority vote of the members, in good standing, present shall be necessary for an election. The votes shall be counted and the results reported at the meeting by a committee appointed by the president.

SECTION 3: All ballots, tally sheets, etc., used in the election shall be placed in an envelope and sealed and the year of the election written on the envelope. The Secretary shall hold the envelope for a period of one year, when it shall be destroyed. The sealed envelope containing the election material may be opened only upon a two-thirds vote of members at regular or special meeting.

ARTICLE VI - MEMBERS

SECTION 1 : Membership in the the AACA is a prerequisite for membership in this Region.

SECTION 2 : Upon receipt of a properly executed application endorsed by a member

and upon submission of a current National membership card, and one year's Region dues, new members shall be accepted or rejected by the Executive Board.

SECTION 3 : DUES - The amount of dues payable to the Regional Treasurer shall be fixed by the Executive Board. All payments of the dues shall be made to the Regional Treasurer. Dues are for the fiscal year January 1st. thru December 31st.

SECTION 4 : Termination of Membership - The membership of any Regional member may be terminated by the unanimous vote of the Executive Board for conduct unbecoming a member of the AACA, or any other cause , upon giving the member in question full opportunity to hear and reply to the charges and reasons for such action. Each member is responsible for the conduct of himself, his family, and guests. Any member whose Regional dues are not paid the last of February shall be dropped from the Regional Roll. After March 1st, in order to be reinstated, a properly executed application is required.

SECTION 5 : Honorary memberships in this Region can be granted by the Executive Board. Such members shall pay no dues in this Region and shall have no right to vote at any meeting of this Region or hold office; but will have all other rights and privileges. If the said honorary member of this Region is not a member of the AACA, the Region shall bear the expense in such club for such honorary member.

SECTION 6 : "Member in good standing " means for the purposes of these by-laws that said member has paid all dues and assessments levied by the Antique Automobile Club of America (National) and this Region, and has met all other requirements for membership in this Region.

ARTICLE VII - MEETINGS OF THE MEMBERS

SECTION 1: The Region shall hold an annual meeting during the month of November on such date, time, and place as the Executive Board shall direct. The business of this meeting shall be the election of officers, report of officers, and any other business at hand.

SECTION 2: A regular meeting of the Region members shall be held once each month at a time and place as the Executive Board may designate, except when the date conflicts with a national holiday.

SECTION 3: In all matters of voting, only members in good standing may vote, and the result will be determined by a simple majority of the members voting at the meeting.

SECTION 4: When a special meeting is called, the Secretary must give written notice to all members, postmarked not less than seven (7) days before the date of the meeting.

SECTION 5: Definition - "NOTICE" shall mean conveyance of information requiring notice or having the information concerning such meeting published in the Regional Publication known as the "SPARKPLUG."

ARTICLE VIII - REGIONAL REQUIREMENTS BY AACA

SECTION 1: The members of the Region shall not, as a group, use the name of AACA in connection with a commercial or charitable project in a manner implying sponsorship of the AACA or the Deep South Region.

SECTION 2: The Region or its chapters shall not hold any activity in conflict with a National event of the AACA.

SECTION 3: Announcements of Regional activities must be sent to the National Vice President in charge of activities.

SECTION 4: The names and addresses of all Regional officers and members must be sent to the National Secretary/Treasurer each year as required by AACA.

SECTION 5: The AACA is a nonprofit organization. The members thereof shall not be entitled to any individual or collective interest, participation, share, right and/or property right in and to the assets of the Club thereof. No dividends, pecuniary profits, stock dividends, or payment of like manner shall ever be declared or paid to the members of this Club or Region thereof.

ARTICLE IX - CHAPTERS

SECTION 1: Upon compliance with the requirements of the National Board of Directors, one or more Chapters may be formed as circumstances dictate within the geographic area of a Region.

SECTION 2: The members of every Chapter shall be members in good standing of the Antique Automobile Club of America and the Deep South Region.

SECTION 3: Each Chapter shall be under the jurisdiction of the Regional President unless special exception is authorized by the National Board of Directors.

ARTICLE IX - REVISIONS OR ADDITIONS TO THE BY-LAWS

SECTION 1: No revisions or additions shall be made that nullifies or alters any part of the National Constitution or By-laws.

SECTION 2: These By-laws should be reviewed on an annual basis with changes and revisions made for the welfare of the organization. All changes and revisions shall be approved by a majority vote of the Regional members in good standing upon written notice to all Regional members stating the proposed changes. This notice will be postmarked at least seven (7) days prior to the meeting date.

ARTICLE XI - PROPERTY

SECTION 1: Property is defined as the Club House, land under lease from the City of Mobile, located at 951 Forest Hill Drive, Mobile, Alabama 36608, and any contents thereof. This also includes any future structures erected or placed on said site.

SECTION 2: No funds will be expended for repairs to the property without the approval of the Executive Board or a majority of the membership at a regular or special meeting. The amount of funds expended by the Executive Board shall not exceed the amount previously approved by the membership. No funds will be expended for improvements to the property without the approval of a majority of the membership at a regular or special meeting.

SECTION 3: In the event of a natural disaster or emergency, the Executive Board will have the authority to expend funds for emergency repairs for the protection of life or property.

ARTICLE XII - PERSONAL LIABILITY

SECTION 1: All persons or corporations extending credit to this Region, extend it only to the Regional Club, and not in any way is it construed toward the National organization. Any claims or liens levied against the Region are only against the property of the Region and no officer is responsible, providing he has not endorsed the line of credit personally.

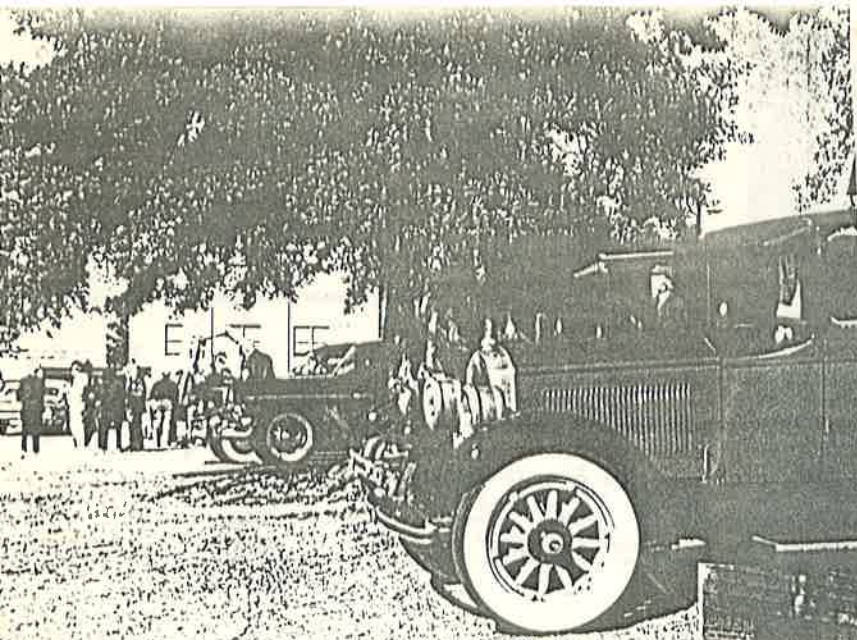

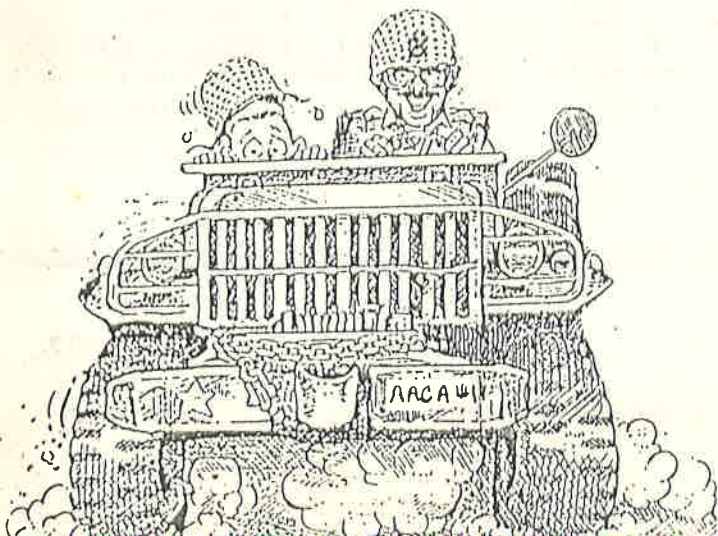
