LaVerne Hopkins Honored as DSR's First Life Member at Christmas Party

On December 7 when members gathered to enjoy the festivities of the holiday season, one lady was surprised to find she was the first recipient of an award established only one month earlier. LaVerne has continued her membership in AACA and DSR after her husband, Vernon, died in early 1993. "Hop" served as Chaplain for many years and LaVerne helped with any task she was asked to do. She has been a member of the Calling Committee for longer than anyone can remember. During her years of membership she has been hospitalized numerous times, both in Mobile and New Orleans. Only a year ago she went in on the day after Thanksgiving not realizing that was only the beginning of nearly two months of hospitalization and rehabilitation.

She seriously considered not renewing her membership for this next year feeling that due to her physical limitations, she is unable to make a significant contribution to the club. However, when she was approached about continuing on the Calling Committee and reminded of all the things she does for DSR, she was persuaded to change her mind.

Not many people would continue to live independently and unassisted with the physical restrictions life has imposed on LaVerne, but she does. Fewer still would be willing to commit to serving on a club committee. Perhaps there is a lesson to be learned here for all of us. Or perhaps, being a transplanted "Memphis Belle" and the epitome of southern grace and charm, this lady is only displaying her true nature which is if she is needed to do something, she will do it. As a DSR life member, she will continue to pay national dues

but local dues are waived forever. Her name is the first on a plaque which will be hung in the clubhouse that will await the next recipient.

This was the first year we were able to hold the Christmas party in our building and it seemed to work out nicely. The meal was catered at a very reasonable cost, the clubhouse was decorated by some of the members and looked beautiful. Everyone pitched in when it was over and clean up was done in short order.

The installation of the 1997 officers was conducted at the Christmas party with Mike Williamson assuming the office of Vice President and Carl Bailey taking over as Treasurer. All the other officers are continuing from 1996 for another term.

The collection of money for sponsoring two children from the Salvation Army's Angel Tree served a two-fold purpose. Thanks to Betty Cordell who baked a 24-layer Torte Cake that was raffled off, we collected a little over \$130. The money left over from the Angel Tree collection and what was left after expenses for the party will be used to treat "Nick & Jamie" and their family to Christmas dinner and some video movie rentals for their entertainment. These boys, ages 12 and eight respectively, live near our clubhouse and both have the rarest and most debilitating form of MD.

It was a first for our group to play "Dirty Santa" and with 58 people in attendance, it could have lasted all night. However, the gifts were moved around quickly with some folks getting the one they wanted before it was declared "dead" and could not be exchanged again.

Adjournment came at 8:30 PM on a motion from Mike Williamson. Hershel Whigham offered the second.



Reminiscing the Model T

The first Model T Ford was assembled on Oct. 1, 1908. It was powered by a 4-cylinder, 20 horsepower motor with a wheelbase of 100 inches, a weight of 1200 pounds and a top speed of up to 40 miles per hour. The Model T was designed by C. Harold Wills, assisted by Henry Ford who stressed it needed high ground clearance for rural areas where roads were poor or non-existent.

The first Model T Fords sold for \$850.00; however, with the advent of the moving assembly line in August 1914, Ford Motor Company was able to lower the price to \$290.00 by 1924. With the Highland Park Plant at full production for the Model T, assembly time was cut from 12 1/2 hours to about one car per minute.

On May 26, 1927 Model T production ended when the 15 millionth Model T Ford was made and so ended an era when Henry Ford put America and the world on wheels, making the auto affordable for nearly everyone. From "Automobile of America" Published by Automoblie Manufacturers Assoc. ,Inc.

EPA, Paranoia and You

As they say, sometimes you have a real reason to feel paranoid, because someone really is after you. In this case it is the Environmental Protection Agency.

A couple of news items of late, one about the U.S. EPA and the other about the California EPA are enough to scare you. In the case of the U.S. EPA, President Clinton is proposing that his pet agency be given the power to confiscate property of those who are accused of polluting.

Carol Browner, EPA administrator said that polluters should be treated just like drug dealers where those accused of these activities can have their property seized on the suspicion alone, with the presumed culprit having to prove his innocence. Now she says that just like drug dealers, those who are accused of polluting the air and water should have their assets taken away. This is made possible under the forfeiture procedures now in place and used in so many other cases. For example, remember the case of a few years ago when a woman had her 87 acre farm taken away, which had been in the family for generations, because DEA found plants of marijuana sprouting up between her tomatoes? Her son apparently thought they would give added flavor to her garden produce. The DEA took away her farm without a trial and now she has to prove in court that she knew nothing about the odd plants. That was some five years ago - she has little hope of getting her farm back.

If this same power is to be given to the EPA for presumed polluters, we will no longer have a government of laws, but of misguided zealots who are the enemies of liberty. Some may call this liberalism, but it is more properly called "illiberalism"

The second piece of news is also scary. The Office of Environmental Health Hazard Assessment of the California Environment Protection Agency has issued an order to have destroyed all reports, research data and other internal records that differ from their administrator's final decisions. I guess what this means is that they only want history to

reflect that they are right. It sounds a little like the Soviet Communists' manipulation of historical data to reflect the rightness of the policies.

The deputy director of the California EPA says this policy is simply consistent with managing records in an orderly manner. This will protect sensitive "pre-decisional" deliberations and promote "robust internal discussions."

Wiping out all data that conflicts with the administrator's decisions promotes nothing of the kind, but instead gives the impression that there was only one side--that of the all-knowing administrator.

I hope that all of you realize the seriousness of the direction we are headed, for it goes far beyond the protection of collector cars. The cars are what got our attention about the direction of government. Maybe there is reason for paranoia?
